Exercise 2: Applying the City Planning Toolkit

Zoning

Zoning is the City's primary tool for regulatinglanduses and implementing the policies of the comprehensive plan. Within each zoning district, the zoning code imposes land use controls that regulate what can be built on individual parcels of land.

Buying & Selling Property

Every time the City buys or sells any property, the intended use of the site needs to be consistent with the comprehensive plan.

Public Realm Improvements

The City, Hennepin County, MnDOT, and the Minneapolis Park and Recreation Board have control over how streets, sidewalks, and parks function and look.

Inspections and Enforcement

City staff conduct site visits to properties that have received zoning approvals, hold a business or rental license, or require other permits to confirm the property's use or building is meeting City regulations and codes.

Transit

Minneapolis works with Hennepin County, MnDOT, and Metro Transit to design and maintain the bus and light rail system so it most effectively gets people to jobs and other destinations.

Business Assistance

The City of Minneapolis works with businesses to start, stay, and grow in Minneapolis through a variety of grant and loan programs.

Housing Resources

Minneapolis administers programs for the development and preservation of affordable and mixed-income rental and ownership housing that is targeted to supportive/special needs, seniors, large families, long-term/ perpetual affordability, corridor/ transit/density, and mixed-use.

Workforce and Training

City programs under the oversight of the Workforce Council include services for low-income adults, dislocated workers, and youth. The purpose of this exercise is identify strategies that the City should be doing in order to achieve equitable outcomes. Referring to the tools to the left, and the story maps, answer the questions below.
